Between July 28th and August 4th, 2007, SES Research conducted a national random telephone survey of 1001 Canadians 18 years and older.

The aggregate survey results are accurate $\pm 3.1\%$, 19 times out of 20. Margins of accuracy are wider for subgroup samples. Results may not add up to 100% due to rounding.

The initiative was part of the SES National Omnibus Survey and was registered with the Marketing Research and Intelligence Association of which SES is a Gold Seal Corporate Member.

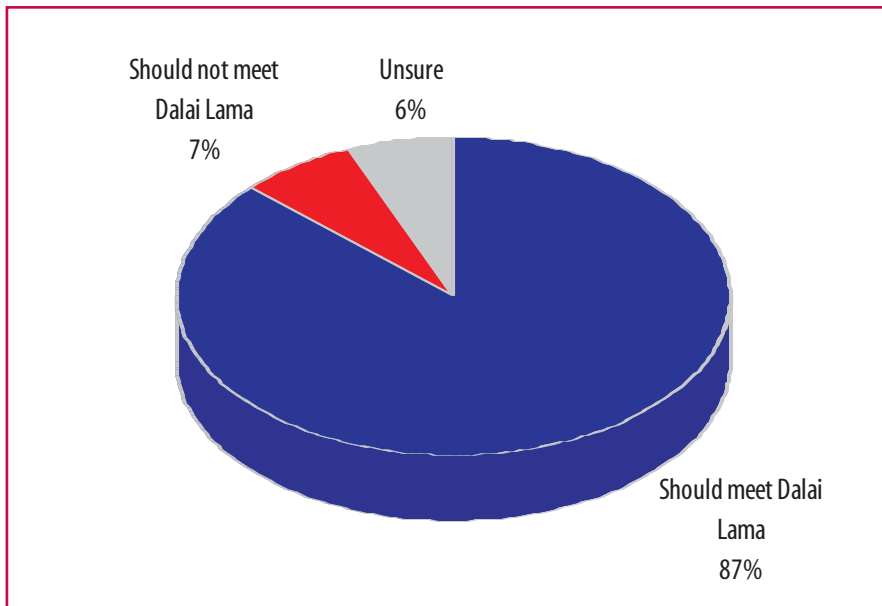

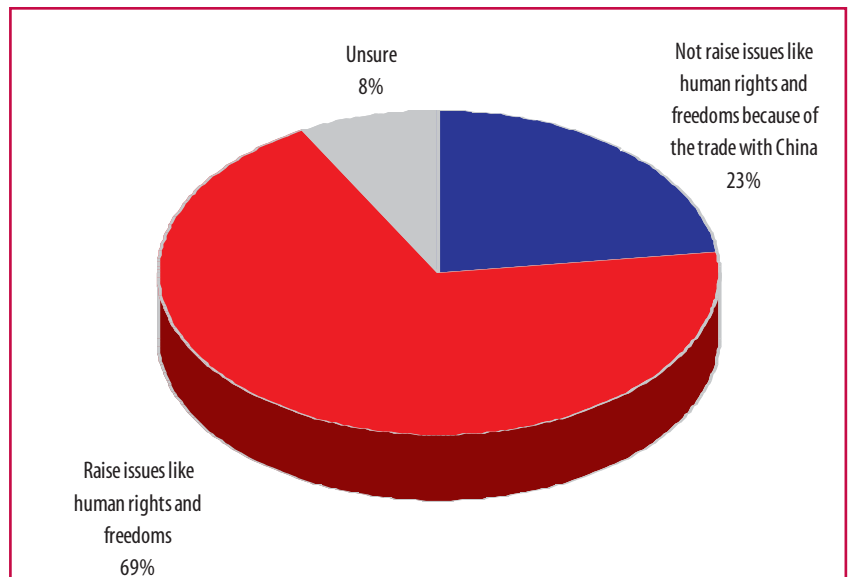
