

## Ontarians Want Pitbulls off the Streets New Poll Finds Strong Support for Law Banning Ownership

Ottawa, September 16, 2004 - A provincial survey of Ontarians released by polling firm SES Research indicates that a majority of Ontarians would support a law banning the ownership of the pitbull breed of dog.

Current SES polling indicates that almost six out of ten (58%) Ontarians either strongly support or somewhat support a law banning pitbull ownership, while only a quarter (26%) oppose such a law. Fourteen percent (14%) said they were unsure.

"A majority of Ontarians want the pitbull breed of dog off the streets" said to SES President Nikita Nanos. "The ferocity and frequency of the attacks have likely had a psychological impact on the perceptions of Ontarians."

SES's Ontario Omnibus Survey is conducted every four months. It is based on a random telephone sample of 500 Ontarians, 18 years of age and older and was conducted on September 11<sup>th</sup> and September 12<sup>th</sup>, 2004. The margin of accuracy for the survey is 4.5 percentage points, plus or minus, 19 times out of 20. Validation of the demographic profile of respondents indicates that the poll is a fair representation of the Canadian voting populace.



## **COMMENTARY**

When asked if they would support a law that would ban owning the pitbull breed of dog, about six of every ten Ontario voters (58%) would support such a law. Significantly, 42% of Ontarians had strong opinions in favour of a ban. While 58% supported a ban, 26% opposed the ban and 14% were unsure

## THE METHODOLOGY

On September 11<sup>th</sup> and September 12<sup>th</sup>, 2004, SES conducted a total of 500 telephone interviews across Ontario with eligible voters. Aggregate results of the survey are accurate to within 4.5 percentage points, plus or minus, 19 times out of 20.

Validation of the demographic profile of respondents indicates that the poll is a fair representation of the voters of Ontario.
